Monitor Lake Water Quality – Solitude Lake Management (SLM) – Justin Foss & Carl Price

Carl showed photos of the Southern Hills lakes compared to other nearby lakes at Sequiota and near Jack Henry. The Southern Hills lakes look quite a bit better due to the treatments.

In March, Solitude will resume the 2 treatments per month (it has only been 1 per month for the winter). They were on site last week and had no concerns. The reports are posted on the CID website.

The Sonar herbicide will be applied in the spring to treat the algae ahead of growth in the upper lake. It is in addition to the typical treatments. All applicators are licensed and the products are EPA approved. The nanobubbler will continue to be use (located on Chip's property). It can be a little loud when running. This will be looked into to see if the volume can be reduced.

Strategy for dam/spillway maintenance -Carl

The City has been reviewing the condition of the outlet of the middle lake that has been undermined due to erosion. They have hired Palmerton & Parrish to design the repair.

Lake common area maintenance - Carl

Your Choice Lawn Care (YCLC) will continue to provide maintenance. Trash clean up is needed on the upper lake island. Carl will relay to YCLC.

A neighborhood clean up day was suggested.

NeighborWoods Update

UPCOMING EMAIL BLAST

Southern Hills Residents -

The City of Springfield has a NeighborWoods program that provides street trees installed at no cost. The trees must be installed by the City within the street right-of-way. To help everyone understand where this strip of land is in relation to their property, city staff have marked up the attached map. For example, the "10" along Southern Hills Blvd indicates there is a 10-foot strip of land measured from the back of curb that is public right-of-way. This is the strip where public trees may be installed.

If you believe you have room in the strip in front of your home, and you are interested in a tree, please contact <u>southernhillslakes@gmail.com</u>. We will provide you with the contact information and form to complete. There are a total of 75 trees that will be available. They are on a first come first serve basis between now and May 1, 2020. You will be required to water the tree during its establishment.

Once the city has reviewed your form and verified the location is suitable for a tree (ex. no conflicting utility lines), then a tree will be scheduled for installation during the fall/winter of 2020.
